MEMBERSHIP DUES

As mentioned in our last newsletter, it is now time to renew your membership. I ask all of you, those who are not life members, to please mail your dues to us as soon as possible. Avoid the rush. Since the per capita increase failed at the convention, we get to keep the ten dollars of your dues for post operating expenses.

WHAT'S BEEN HAPPENING

For those of you who have email, at the risk of repeating myself, I will go over the results of the convention, for those who do not have email.

As stated earlier, the per capita increase that was proposed for two years to help pay for the CWV hosting the Arlington Veteran Day Wreath ceremony did not pass.

The resolution on proxy votes also failed. All it would have done is prevent a department or post without a department from speaking for a department or a post without a department from voting for a department or post without a department who does not have any delegates present at the convention. Which is the way most, if not all, other organizations work.

The resolution to correct the language in the constitution and bylaws passed.

A resolution stating that the commander cannot appoint a special committee without the approval of the executive board passed.

A resolution to require spending non budgeted money to be approved by the Directors. Passed. The reason for this is, the Commander, or other national officer was allowed to spend up to \$2500 on a project or

contract without anyone else knowing about it until after the fact. .Now it has to be approved.

The last resolution, which passed, had to do with a waiting period of time required before a past national commander or past national chaplain had to wait before they could be considered for the Order of St. Sebastian.

So much for the resolutions. On Saturday we had the election of officers. Before we left for the convention, Ann was advised that she might run for the office of welfare officer. Her position as VAVS Deputy was an appointed position and she was told that the probable incoming commander had another person in mind and that she, Ann, might consider running for Welfare Officer. She was elected. That gives two members of our post on the national board.

MOVE

Ann Roberts and I worked many hours preparing a power point presentation on The Catholic Center. We rehearsed it several times. When we got to the convention we discovered that the hotel did not have a projector to use. So, we quickly had forty copies made and I went through the proposal as the members present followed in the copies.

Last November the National Board voted that there be at least three proposals be brought before the Directors at the March board meeting and they would make their recommendation on at least two. Well, at the March meeting, Kansas City was the only proposal. With only one proposal, ours, presented at the convention, we should have had a vote.

So, when the convention began, Kansas City was the only proposal on the table. After I presented our proposal, there was a call for a vote. Then New York and Pennsylvania said they had proposals, but didn't know they were supposed to give theirs at the convention. So, since it was lunch we recessed.

After the recess, Pennsylvania withdrew. The department commander said that there was no way he could compete with The Catholic Center. But, New York still had their proposal;. Every point I had made he countered. I stated that rent would be \$600 a month and his department had a cardinal and a couple of bishops as members, etc. Nothing like being blindsided. The result ended up with the commander will appoint a

committee and they will visit both sites and report to the whole board at the November meeting.

I have written to the national commander asking to be informed when they will be in Kansas City so we can be present to answer any questions they may have.

Needless to say I was fuming. But, after I cooled down a bit, I just gave it all to the Holy Spirit. If the national office is supposed to move here, it will and New York can't do a think about it.

So, keep praying.
